PUBLIC COMMENT

There were no comments submitted.

COMMUNITY CORRECTIONS AND RRJ STATISTICS

Mrs. Hale provided the following statistics for RRJ:

Video Arraignment/Booking/Release statistics for the month of January, 2023: Fredericksburg Circuit Court–28, Fredericksburg General District Court-42, Fredericksburg Juvenile and Domestic Relations Court-7. Spotsylvania Circuit Court-32, Spotsylvania GDC-89, Spotsylvania Juvenile and Domestic Relations Court-13. Stafford Circuit Court-44, Stafford General District Court-111, Stafford Juvenile and Domestic Relations Court-38. King George Circuit Court-12, King George General District Court-17, King George Juvenile and Domestic Relations Court-0, other-46.

The total numbers for the month of April were as follows: Video Arraignments: 479, Other Status Hearings: 11. Bookings: 796, and Releases: 768, for a total of: 1,564. The Average Daily Count: 907. The Community Corrections Program totals were as follows: Pretrial Supervision: 838, Community Based Probation: 748, Veterans Docket: 6, Behavioral Health Docket: 8, Adult Drug Court: 39, Juvenile Drug Court: 2, Work Release: 10, and Electronic Monitoring: 3, for a total of 1,654 individuals in Community Corrections programs.

RACSB UPDATE

Ms. Jacque Kobuchi presented the RACSB report and the diversion data for the second quarter of Fiscal Year 2023. There have been a total of seventy-three assessments in the aforementioned period. Of those, seventeen individuals met the criteria based on the assessment and agreed to services. Sunshine Lady House is temporarily closed due to workforce shortages. Other programs are struggling with workforce shortages which impact service delivery, this includes issues in both behavioral healthcare shortages and law enforcement shortages. The Crisis Intervention Team held a 40-hour training session in January with 22 participants. CIT held a dispatcher training session in with 8 participants.

MAGISTRATE UPDATE

No report was provided for the Magistrate Update.

DISTRICT 21 OVERVIEW

Due to Mr. Ed Simmons being absent during the meeting, Ms. Hale presented the report for District 21 Probation and Parole. She presented total PO positions: 29; 6 vacant PO positions; 1 vacant senior probation officer position. During this time, the office is supervising 260 high level cases; 1,376 medium level cases; 222 low level cases; 263 cases pending intake, and 750 cases are being supervised via voice-verification. Gang/threat group members actively being supervised are 135. There are 192 registered sex offenders on some form of supervision, 13 of which are being monitored by GPS. In the last three months, there have been 287 major violation reports and 71 Presentence Investigation Reports have been submitted to local courts.

A total of 2,150 drug tests have been completed in the last three months.

Decision Points, Sex Offender Awareness Program (SOAP), sex offender treatment, sex offender treatment aftercare, and substance abuse treatment groups are offered in-house. Teletherapy is being conducted whenever possible, but in-person substance abuse treatment has resumed.

Overall, there are 2,592 individuals under probation or parole with the district, which makes the office one of the largest in the central region.

JUVENILE JUSTICE REPORT

Mr. Fearon mentioned a discussion that he had with Ms. Stephanie Garrison who is the Regional Manager for the 15th District. She informed him that no one would be able to report or resume for the Juvenile Justice report until they hire a new director.

ARTICLE XI - Suspension of Rules

Mr. Kevin Hudson made a motion to suspend Article Six-Section 3 in the Bylaws. Section 3 states "The provisions of Article VII may be suspended pro tempore by the unanimous vote of members present at the meeting of the CCJB or a committee. No other provisions of these Bylaws may be suspended." Judge O'Connor seconded the motion.

APPROVAL OF MEETING MINUTES, December 1, 2022

Mr. Fearon proceeded with the approval of the meeting minutes for December 1, 2022, after Mr. Hudson suspended Article Six in the Bylaws. Lauren Whitley made a motion to approve minutes; Travis Bird seconded the motion. The motion passed unanimously.

LETTERS OF SUPPORT

Ms. Hale bought up four letters of support and has requested for Mr. Fearon to sign. Letters one through three are for Ms. Anna Powers who is at the Supreme Court. The first letter is for Drug Court: Hudson made a motion to approve the first letter, Joe Wickens seconded motion. The second letter is for Behavioral Health Docket: Hudson made a motion to approve the second letter, O'Connor seconded motion. The third letter is for Rappahannock Regional Veterans Docket: Joe Wickens made a motion to approve the third letter, Travis Bird seconded motion. The fourth letter is to the Department of Criminal Justice services for Community-Based Probation and Pretrial services: Judge Levy made a motion to approve the fourth letter, Hudson seconded the motion. All four letters were approved unanimously.

ADJOURN

Mr. Fearon made the motion to adjourn meeting. Meeting adjourned at 4:20 p.m.
