Mr. Fearon proceeded with the approval of the meeting minutes for June 6, 2024. Ryan Mehaffey made a motion to approve the minutes; Kevin Hudson seconded the motion. The motion passed unanimously.

## **COMMUNITY CORRECTIONS AND RRJ STATISTICS**

Mrs. Kelly Carey provided the following statistics for RRJ: Video Arraignment/Booking/Release statistics for the month of July 2024: Fredericksburg Circuit Court-**29**, Fredericksburg General District Court-**66**, Fredericksburg Juvenile and Domestic Relations Court-**10**. Spotsylvania Circuit Court-**40**, Spotsylvania General District Court-**53**, Spotsylvania Juvenile and Domestic Relations Court-**22**. Stafford Circuit Court-**67**, Stafford General District Court-**143**, Stafford Juvenile and Domestic Relations Court-**35**. King George Circuit Court-**4**, King George General District Court-**29**, King George Juvenile and Domestic Relations Court-**0**, Other-**20**. The total numbers for the month of July were as follows: Video Arraignments: **518**, Bookings: **823**, and Releases: **865**, for a total of **1,688**. The Average Daily Count: **1212**. The Community Corrections Program totals were as follows: Pretrial Supervision: **838**, Community-Based Probation: **710**, Veterans Docket: **12**, Behavioral Health Docket: **7**, Adult Drug Court: **47**, Juvenile Drug Court: **4**, Work Release: **4** and Electronic Monitoring: **2**, for a total of **1,624** individuals in Community Corrections programs.

## **BOARD MEMBER UPDATE**

The CCJB said goodbye to Chief Brian Layton and thanked him for his service. Additionally, the CCJB welcomed The Honorable Jane Reynolds and The Honorable William Glover.

## **REAPPOINTMENT**

Mr. Kevin Hudson motioned for the reappointment of Mr. Davy Fearon as the CCJB Chairperson for a second term. Ryan Mehaffey seconded the motion. The motion passed unanimously.

## **RACSB UPDATE**

Ms. Jacqueline Kobuchi presented the RACSB report and the diversion data for July 2024. The Crisis Stabilization Program is back up and running. The Jail Diversion Program did **36** assessments. The Emergency Services Team sent **2** individuals to state hospitals. They are participating in a pilot program for private transportation services. This allows individuals to be transported to area hospitals with a private security company. The company that they are using is Allied. It frees up the need for law enforcement transports. The Rappahannock Area Crisis Intervention Team trained **23** law enforcement officers and **9** dispatchers. RACSB has a therapist assigned to the Spotsylvania County Co-Response Team which served **18** individuals in July. RACSB is recruiting therapists for Stafford and Fredericksburg. They received funding to open a Crisis Receiving Center where people can walk in voluntarily and receive services or law enforcement can drop individuals off. They will be able to ECO them there and it will be an alternative to going to the hospital. They will have beds where people can receive food, a shower, and medications and they can observe individuals. It is still in the planning phase.

Chief Rose stated that they are fully staffed.

## **DISTRICT 21 PROBATION AND PAROLE OVERVIEW**

Mr. Ed Simmons reported that there is a total of **28** PO positions; **4** vacant PO positions. **2168** probationers and parolees on supervision. **449** level high cases; **684** level medium cases; **370** level low cases; **251** cases pending intake; **1347** cases being supervised via ShadowTrack voice-verification. **135** gang/threat group members actively being supervised. **160** registered sex offenders on probation, parole, or conditional release. **12** sex offenders being monitored by GPS. **352** Major Violation Reports submitted in the last three months. **90** Presentence Investigation Reports submitted to local courts in the last three months. **2807** drug tests completed in the last three months.

No updates were shared.
